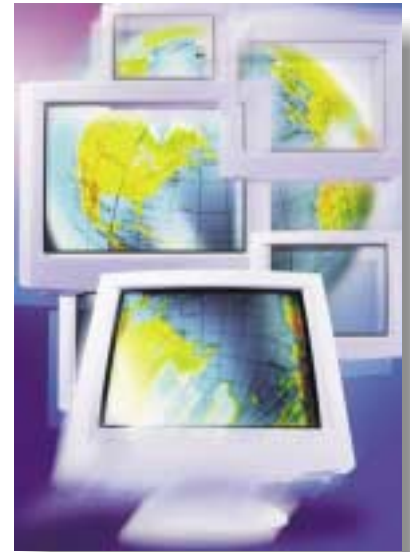
The Firm
